# **OUR HISTORY**

Backpacks 4 SA Kids was launched as a result of two South Australian families supporting a QLD charity called Backpacks 4 Aussie Kids.

Through involvement in the charity, it became very clear that there was substantial support and demand in SA for a project similar to Backpacks 4 Aussie Kids and that creation of a locally based charity was not only viable but in fact would thrive within our amazing supportive community.

To this end, work was undertaken to adapt the project to suit the needs of children who have been displaced from their homes within SA, while also incorporating the provision of support to children accessing emergency services such as foster care, domestic violence shelters and youth homeless shelters.

Our initial thoughts were to do a few backpacks between our families with a goal of just 10 backpacks as a starter program. By the end of the first year so many people had joined our goal to make a difference we had supplied 564 backpacks to kids in need. Each year since we have grown and adapted to help fill the needs/demands of our emergency services community.

# CORPORATE PROFILE

Backpacks 4 SA Kids exists to provide resources that contribute to the care, safety and wellbeing of children and young people during periods of dislocation from home and routine care.

Backpacks 4 SA Kids is driven by Rachael Zaltron who is an Adelaide mum with a background in nursing and a passion for helping children and young people.

Growing up, Rachael's family home always welcomed kids her parents were helping during times of family stress and trouble. It wasn't until she grew up that Rachael realised many of the kids were kept 'on track' thanks to her parents' practical help and welcoming home.

The death of Rachael's close friend Lucinda at the young age of 30 prompted Rachael to reflect on how we need to live each day in full and make a difference to someone else every day.

These factors have created a strong desire in Rachael to help others and this led to her volunteering with Backpacks 4 Aussie Kids. But she soon realised that the needs of South Australian kids were different, prompting her to establish Backpacks 4 SA Kids in 2013.



With the knowledge that communities in SA are incredibly giving, Rachael committed to her goal of ensuring that no child going in to State-based care or facing homelessness would be without the immediate essential items needed for their physical wellbeing, plus the 'extras' such as a cuddle toy, to show that people care about them. Remaining committed to her original vision, Rachael and the team have widened the service offering to include Home Starter and Anchor packs to include an older cohort of young people and families who are facing homelessness and hardship.

Backpacks 4 SA Kids have approximately 200 regular individual and corporate volunteers who alone give a total of approximately 5,000 hours of work per year. We also receive donated goods including clothing, toiletries, baby needs, books and toys from community members across the State, via 39 drop off points at venues such as banks, schools, coffee shops and other businesses. In addition, we receive support from organisations, schools and community groups which donate goods and/or give employees time off to volunteer in our warehouse.

#### The financial year of 21/22 started with new relationships and partnerships filled with exciting possibilities. A random phone call from an amazing new philanthropic venture about opportunities to receive stock donations in bulk, sourced by a third party seemed too good to be true, but Backpacks 4 SA Kids was the first charity to be supported by the Bresnahan Footprint Foundation (BFF) with In Kind stock, which was the beginning of change at Backpacks 4 SA Kids with our team working at finding ways to acknowledge the importance and value to the charity of In Kind donations. 80% of our goods provided to the kids this year are sourced through the form of In Kind donations. Despite such an incredible supporter base an ongoing issue for Backpacks 4 SA Kids has been having consistent stock to ensure we meet demand at all times of the year and this focus will be covered in our strategy and planning moving forward. By November of 2021 we had received the grant from the Morialta Charitable Trust supporting and ensuring sustainability for the Anchor Packs program for the year ahead. Acknowledgement of the grant in our social media jumped start a rush of orders from our youth homeless sector showing a real need for such a pivotal program allowing an immediate crisis response with the teens who need us most. With the benefit of this grant, Backpacks 4 SA Kids were able to support an incredible 32% increase in demand for the Anchor Program, an achievement that would not have been made without the integral support of the Morialta Charitable Trust. Backpacks 4 SA Kids were selected to be reviewed by a focus team involved with the Governors Leadership Program (GLF). The GLF group focused on an overview of our goals to ensure sustainability moving forward and whilst we had a couple of different stand points from the group, the Backpacks 4 SA Kids team found it really exciting to be involved in looking at the charity, its core goals, running and future from different perspectives and we felt the venture was a valuable experience to be involved in and reinforced our strategy and planning moving forward was heading in the right direction. Our drive to source our own warehouse in line with our future strategy for sustainability was supported by a donor who would like to remain anonymous. Happy tears were shed when I received a phone call donating \$100,000 to a warehouse fund. A high kick dancing leap in the right direction for the future sustainability of Backpacks 4 SA Kids and a amazing belief in who Backpacks 4 SA Kids and everything we aim to achieve. After many efforts to source a lease for a larger warehouse at a well below commercial value rate, we have adapted our plans and been able to find a short term solution with securing a second warehouse at 700 square metres in size just 5 minute drive away from our base warehouse in Para Hills West. This warehouse is available for use by Backpacks 4 SA Kids for a two year period of time with a potential for a small extension depending on the development of future ventures. I would also like to sincerely thank the support of Phill McMillan who is a specialist in OH&S working towards ensuring our Backpacks community maintain safe working practices and the minimise any risks faced by the team whilst in our warehouses. Overall the year of 21/22 has reinforced all of our plans and strategies to ensure we are on the right track to longevity for Backpacks 4 SA Kids so we can continue to support the kids who need us most in SA. It has highlighted the importance of our partnerships, strengths in support from our community, but also allowed us a different insight into our weaknesses and provided opportunities to review them, learn

from them and develop strategies to better work practices moving forward and this alone is incredibly

exciting for 22/23.

# TREASURER'S REPORT

The 2022 financial result for Backpacks 4 SA Kids produced an operating surplus of \$108,971 with \$100,000 being specifically donated for the purpose of a warehouse building reserve.

It is reassuring that corporate and individual donations remain strong with \$632,245 collected along with \$86,184 in grants. Further donations of goods in kind from a variety of not-forprofits, corporates and individuals are vital to the programs delivered.

Employee costs have increased slightly from the previous year due to program demands, volunteer management and sourcing stock for all programs.

Backpacks 4 SA Kids board and management continue with endeavours to maintain a stable financial position with sufficient funds on hand to meet its current obligations, while also progressively growing the warehouse building reserve to ensure long term organisational sustainability.

#### Report on the Audit of the Financial Statements

#### Opinion
